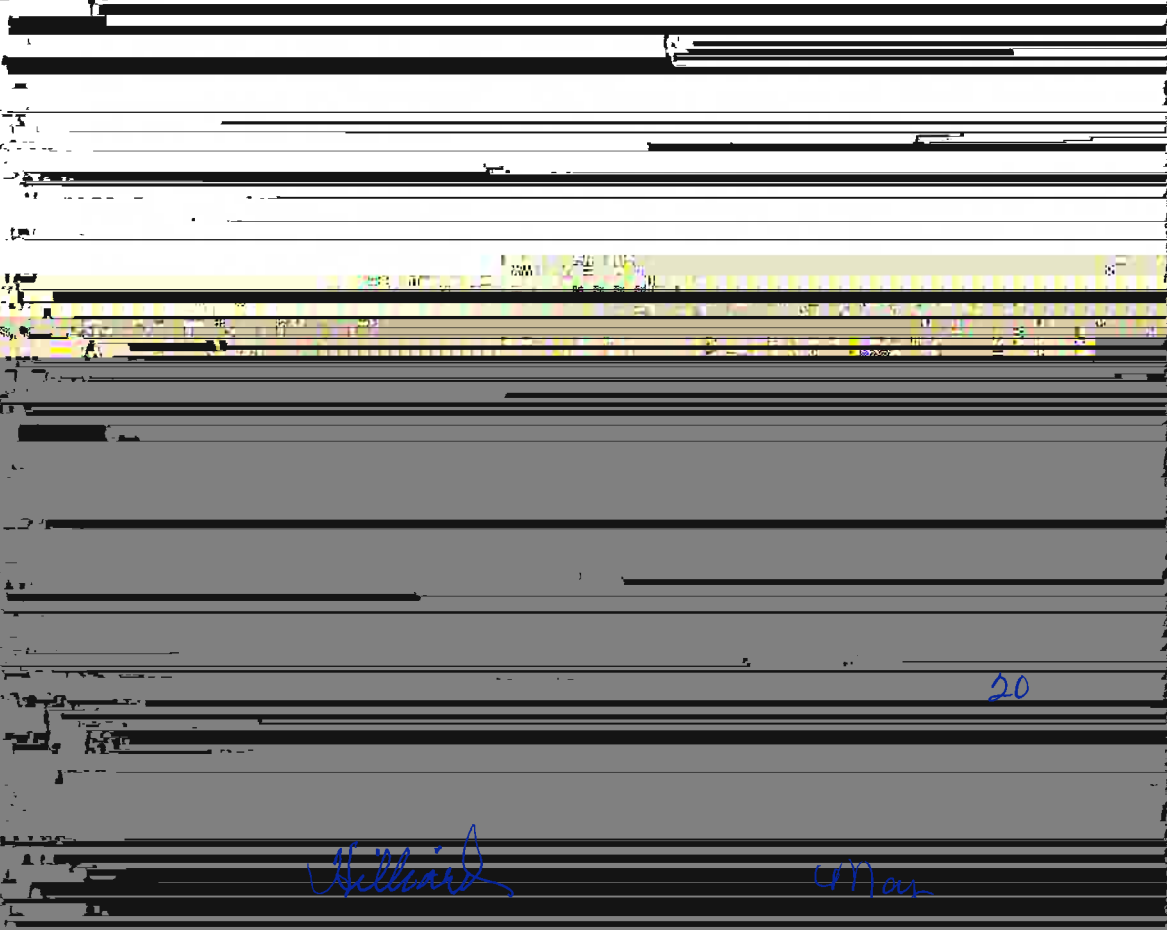
Dr. Hairston, Frank Figgers, Dr. Lockett, and Cynthia Thompson; votes cast against the motion: none. **PASSED**
